



## 12 Days of Techmas - Day 6. Terms & conditions

By entering this promotion, you accept and agree to be bound by the following terms and conditions:

1. This promotion is open to all UK residents, including Isle of Man, aged over 18 years. Excludes residents from the Republic of Ireland and employees of Currys Group Limited or HARMAN, and their families, agents (including affiliates), suppliers and anyone connected to this promotion.

3. All entries received between 00:00 and 23:59 on 19/12/2022 will be eligible for the prize draw.

### 7. The Prize Package
