

TERMS AND CONDITIONS

Only fully completed claims received within thirty (30) days from the date of purchase will be accepted. Upon online claim submission, you will have the option to print your Confirmation Page confirming that your claim has been received. 31 days after the date of registration, you will be able to check that your warranty has been registered at <https://warrantycheck.epson.eu>

4. Epson commercial warranty will apply on any applicable purchases irrespective of this promotion. Its terms may vary per country and product and which Epson company offers this warranty to you depends on the country into which your Epson product was first sold by an Epson company. For full information on service level cover and warranty conditions applicable for the Selected Printers please see www.epson.eu/warranty.
5. These terms do not prohibit in any way your right to exercise any applicable statutory rights.
6. This promotion is open to you if you are aged 18 or over, resident in one of the following countries where one of the Selected Printers was sold to you by an Epson authorised reseller: Germany, Austria, Switzerland, France, Italy, Spain, Portugal, Netherlands, Belgium, Finland, Norway, Denmark, Sweden, UK, Ireland, Hungary, Poland, Romania, Slovakia, Estonia, Lithuania, Latvia, Bulgaria, Czech Republic, Macedonia, Croatia, Kosovo, Montenegro, Slovenia, Malta, Cyprus, Greece, Serbia, Albania and Herzegovina.

 - c) the registration claim form has not been submitted to Epson within thirty (30) days from the date of purchase.
