



Terms & Conditions

1. Subject to the remainder of these terms and conditions customers purchasing one of the Qualifying HP Products can claim a defined cash back amount. This cash back offer is valid only for purchases made during the respective promotional periods for the Qualifying HP Products as detailed in the table below (section 29: Qualifying HP Products and respective promotional periods), specified cash back amounts will not be granted if the particular Qualifying HP Product is purchased outside the respective promotional period.
2. Customers may claim cash back for a maximum of 5 Qualifying Products.
3. To take advantage of the promotion, customers must complete the online claim form (available at "hp.com/uk/savemoney"), and attach proof of purchase in the form of the sellers invoice, via scan or email attachment. Proof of order or dispatch note will not be accepted. The sellers invoice must clearly show the customer details, HP part code of the qualifying products purchased, the purchase price and the date of purchase. The participant must not send original invoices as these cannot be returned. HP must receive the claim form and supporting documents within 30 days after the date of purchase.
4. The promotion is valid in respect of a Qualifying HP Product purchased either directly from HP or an authorised reseller or authorised retailer of HP. 5. Once the claim form and supporting documents have been received, HP will send the customer confirmation of receipt by email from promotions@hp.com. or as soon as possible thereafter. HP will not be liable where claims are processed outside of this timeframe.

9. The recipient of the payment shall fulfil any tax obligations imposed by local tax legislation.

10. The cash back amount will only be paid upon HP's satisfaction that the customer has fully complied with these terms and conditions and the associated instructions.

11. By completing the claim process customers confirm their acceptance of these terms and conditions. Return of the Qualifying HP Product to the seller/reseller following submission of the claim for the cash back will disentitle the customer to the cash back. If a product is returned (thus revoking the sales contract) no claim may be made for cashback. In this case cashback that has already been paid must be fully paid back.

12. The offer is valid only in the UK and Northern Ireland for private end users and business customers. This offer may not be combined with any other promotional offers or special pricing offered on the qualifying products.
