The Promoter

1. Samsung Electronics (UK) Limited, Samsung House, 1000 Hillswood Drive, Chertsey, Surrey, KT16 OPS (the "**Promoter**" or "**Samsung**").

Promotion Period

2. The Promotion will commence at 00:01 (BST) on 29th March 2018 and will continue until 23:59 (BST) on 8th May 2018 (the "**Promotion Period**").

Eligibility

- 3. To be eligible to participate in the Promotion you must be a United Kingdom or Republic of Ireland resident aged 18 or over ("Participant" or "you").
- 4. Employees, agents and any group company of the Promoter, and anyone professionally connected to this Promotion, are not eligible to enter.

How to claim

- 12. If the Promotion Product is purchased from the Currys PC World online store, the Participant will receive their Reward Code by email within two (2) weeks from the date of purchase.

General
